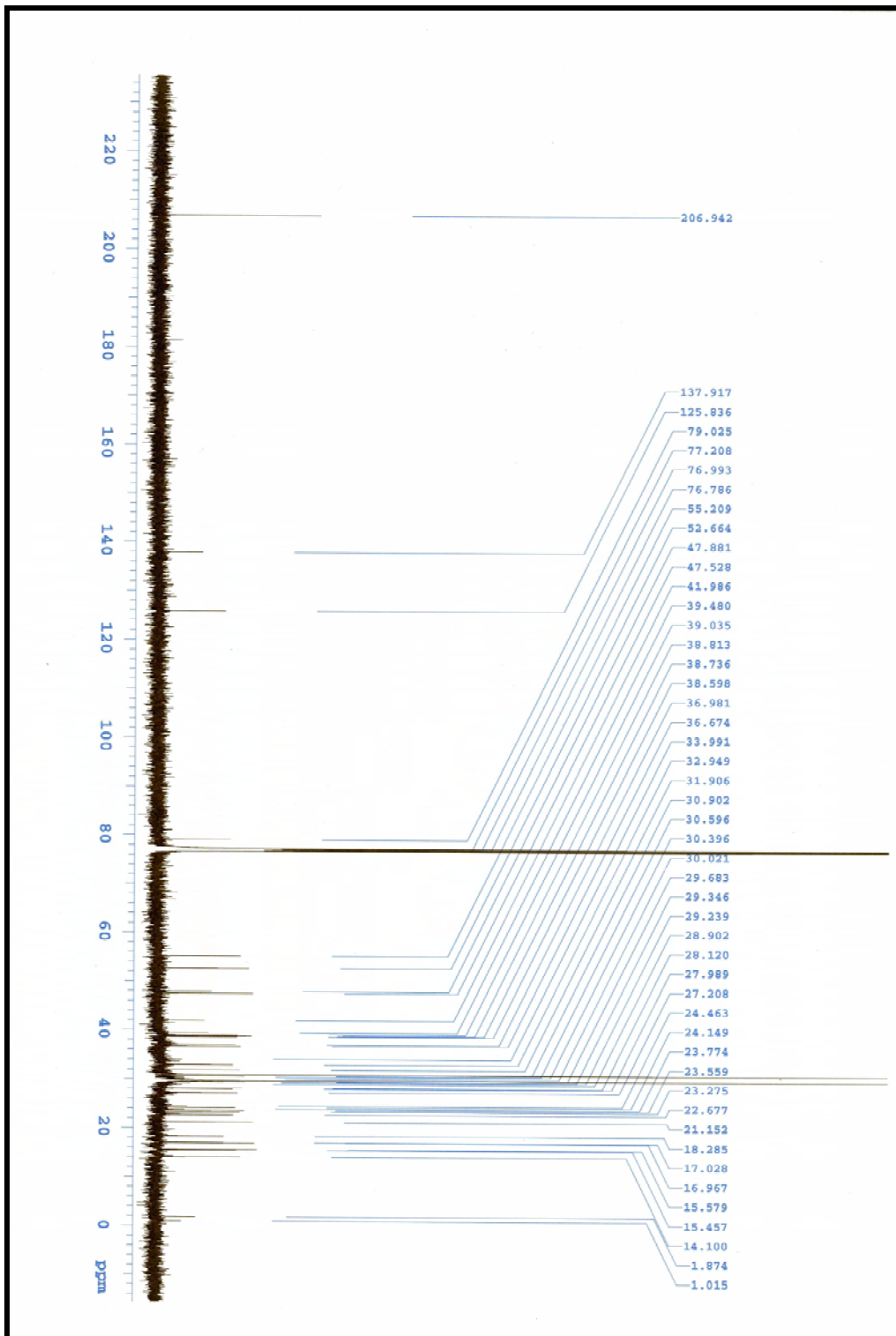

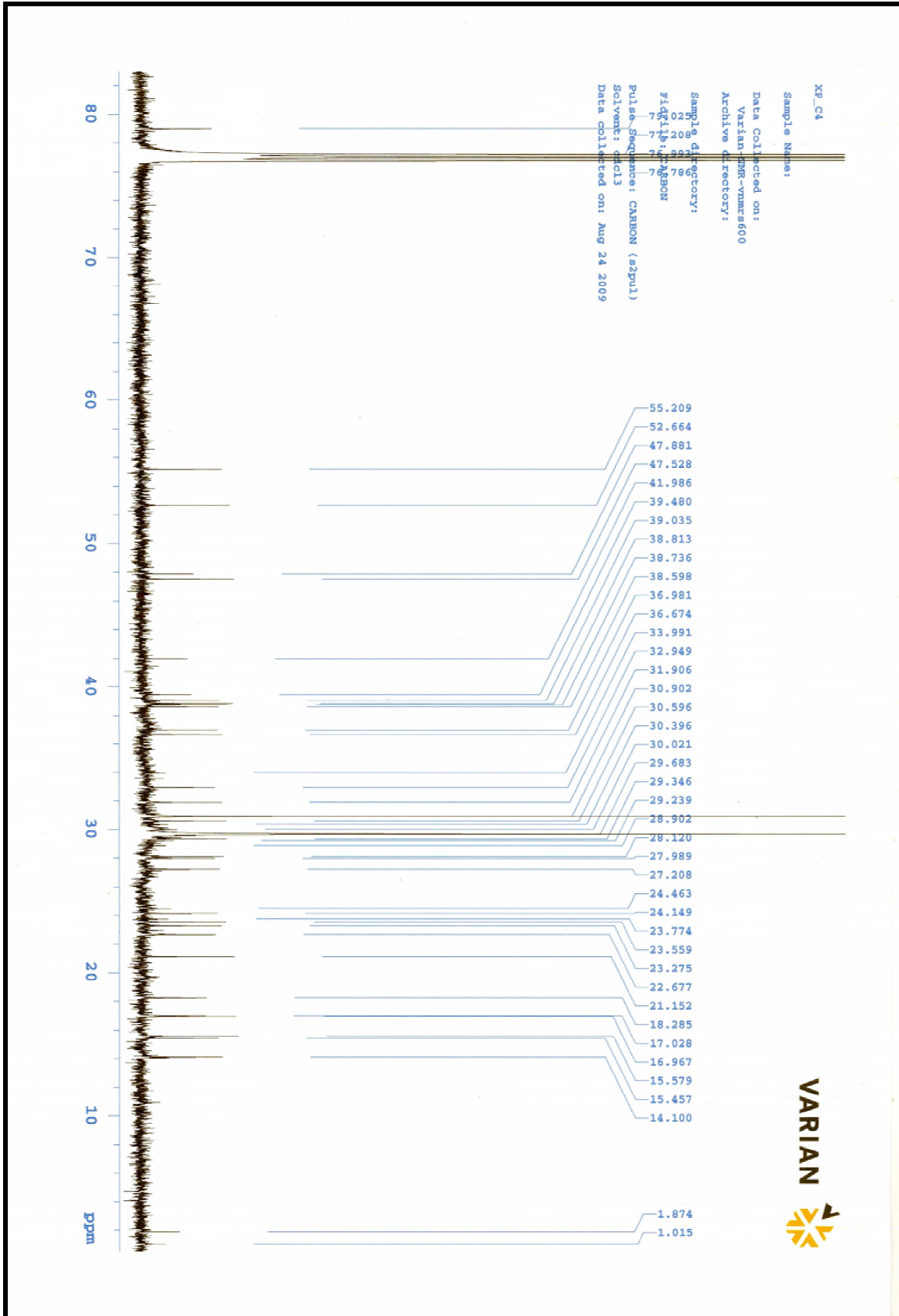

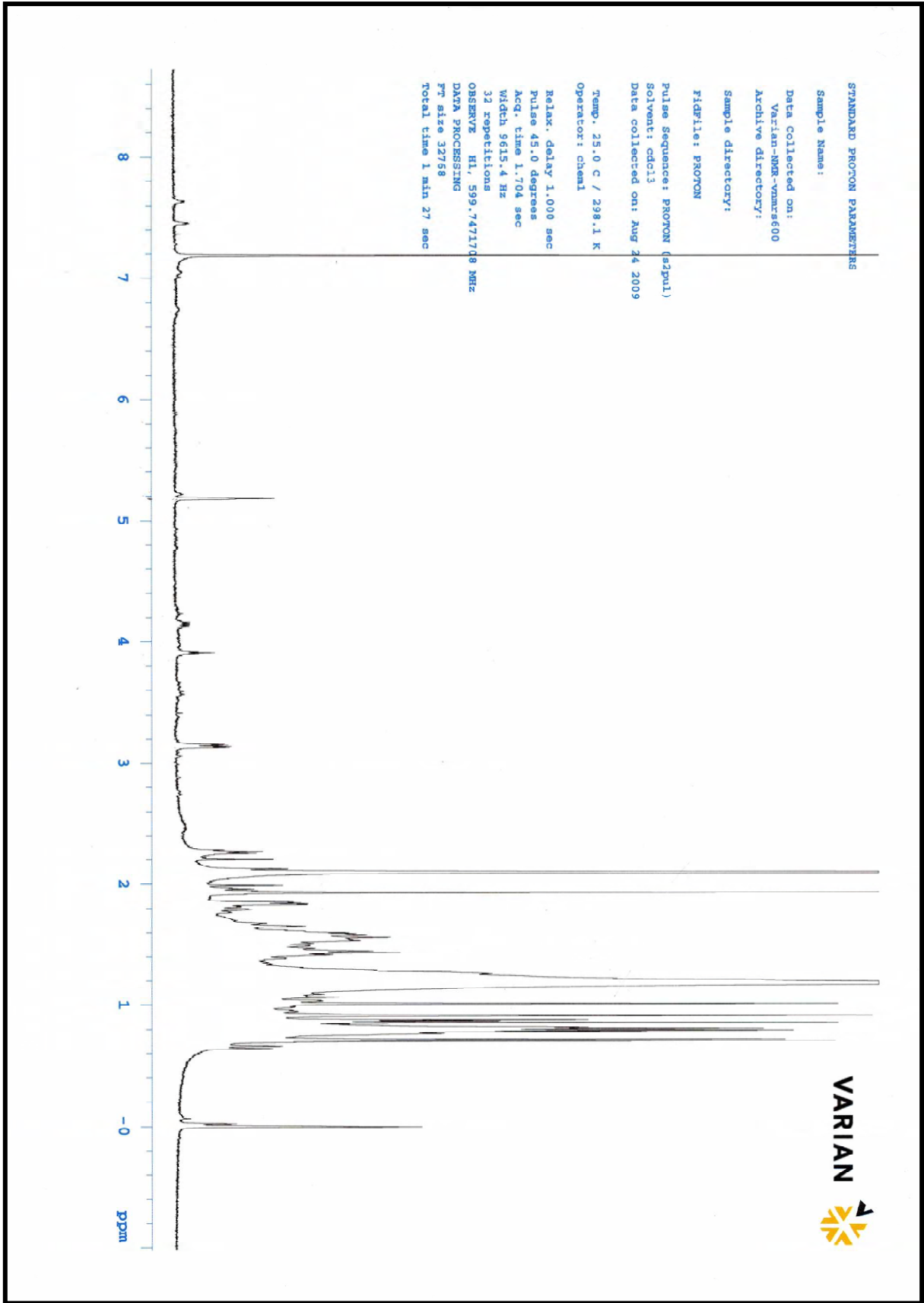

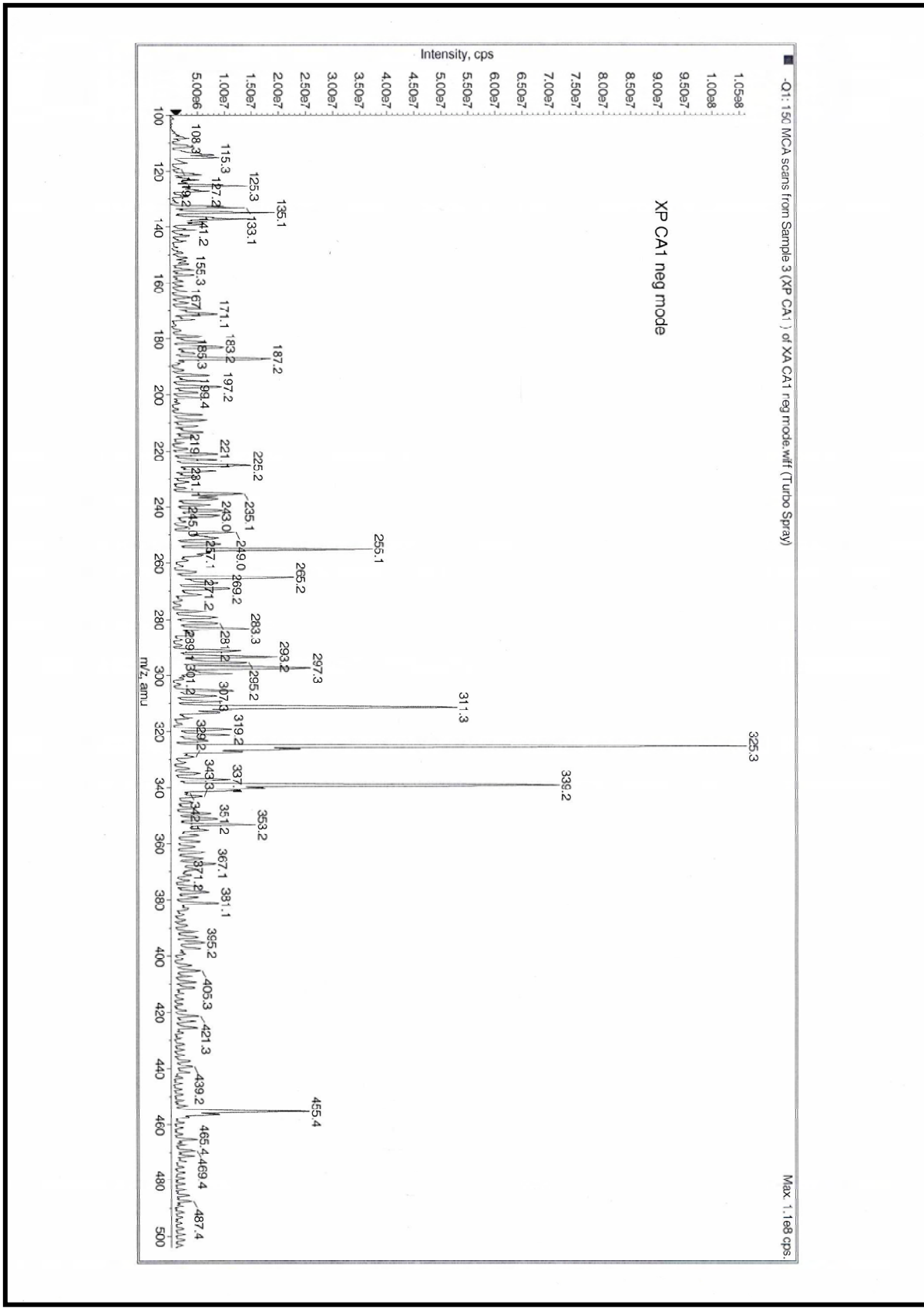
^{13}C NMR spectrum of ursolic acid



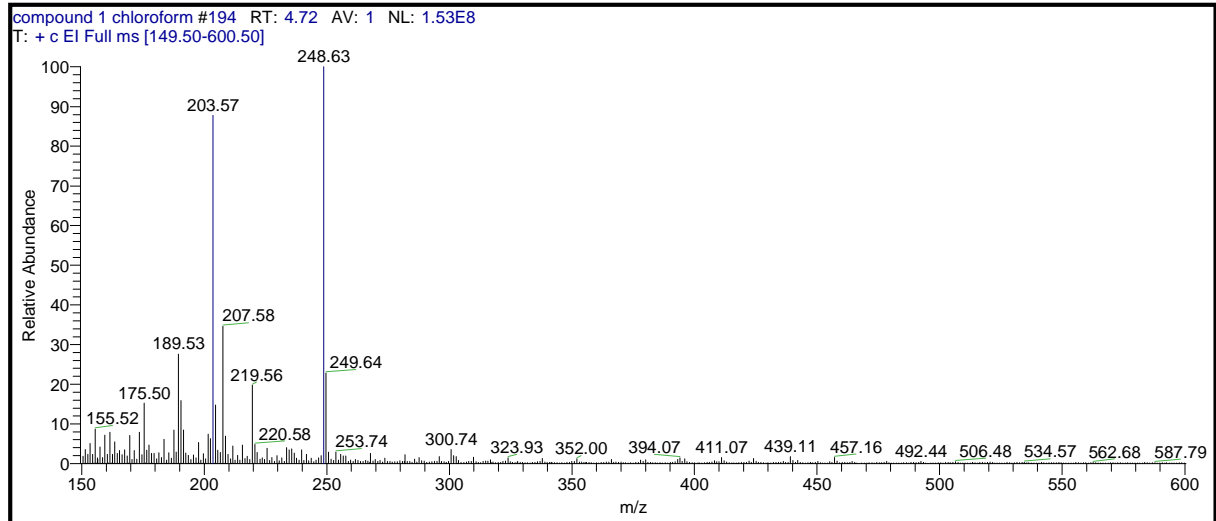
^{13}C NMR of ursolic acid, enlarge/ focused from 0 to 80 ppm



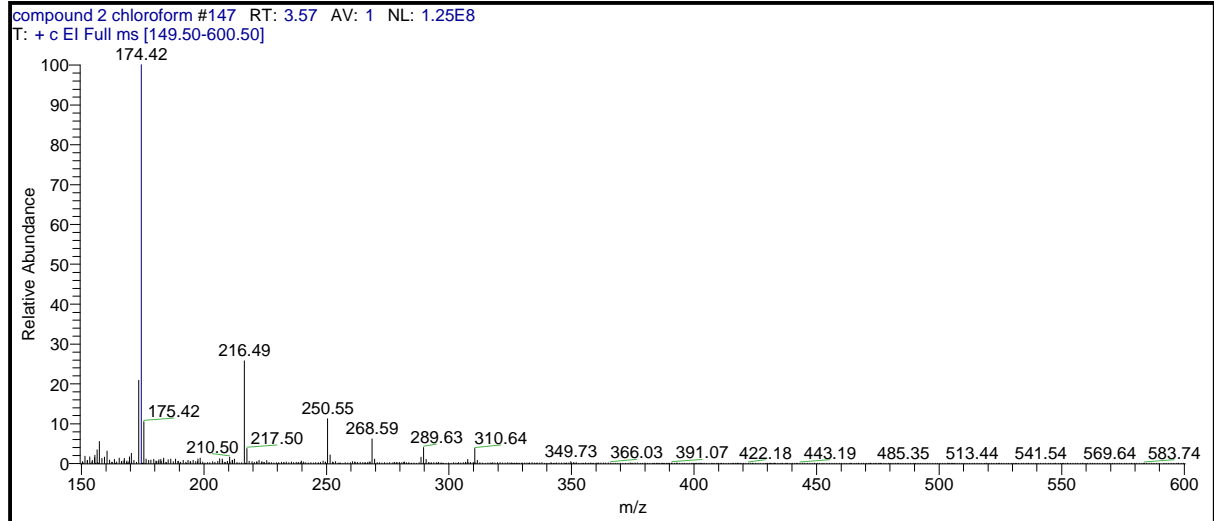
¹H NMR spectrum of compound 1 (ursolic acid)



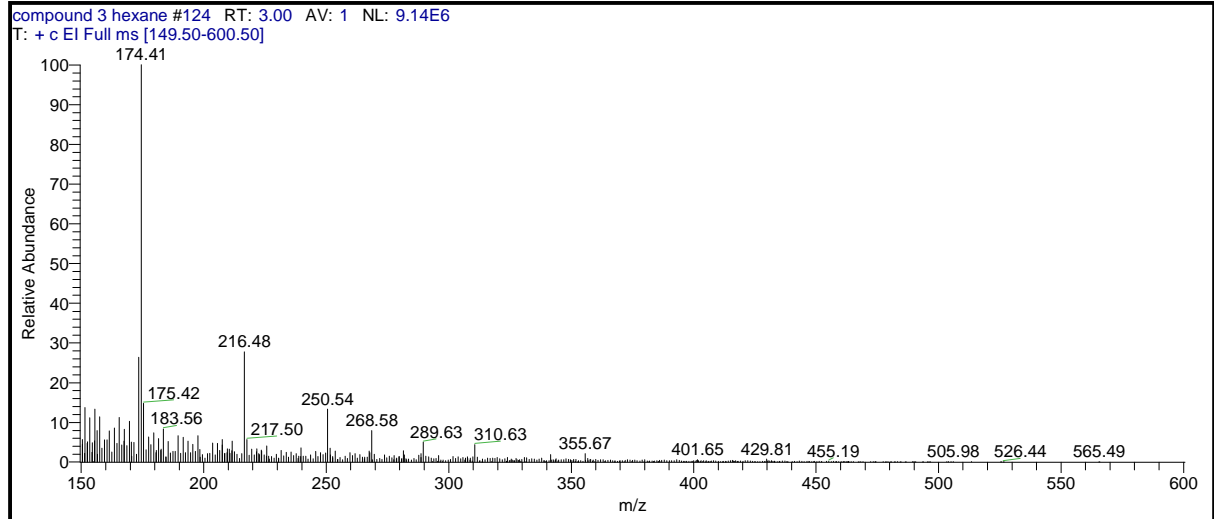
Electron ion impact mass spectrometry (EIMS) of ursolic acid



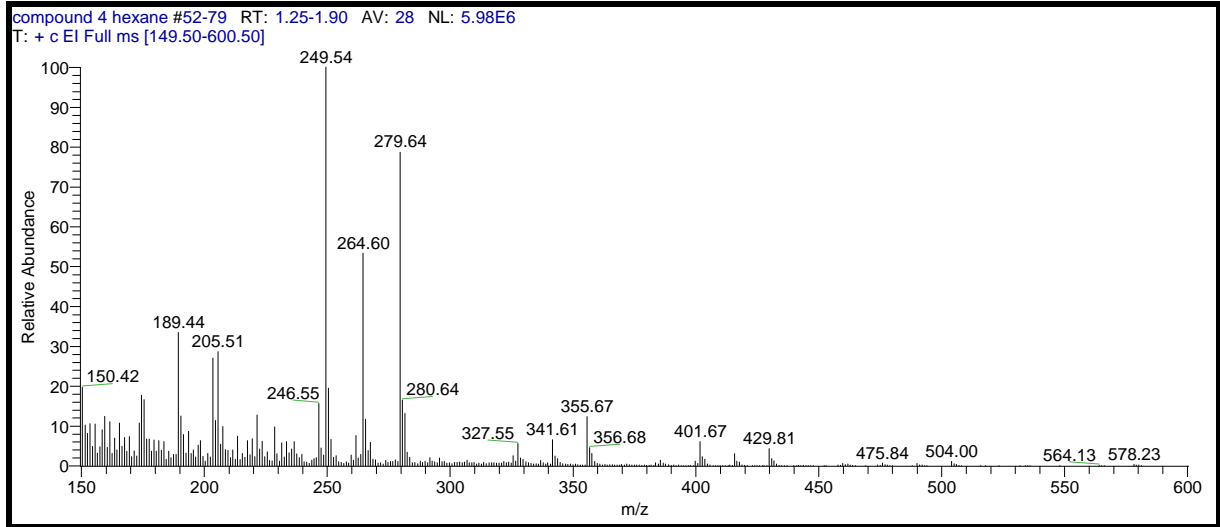
Mass spectrum of ursolic acid.
